Mr. Mohan Reddy raised the question that is all the numbers are on Skill India Portal? Mr. Goel replied that the projects may be under execution stage, O-CEO confirmed this. He further updated that all the numbers are from Paid RPL programme. Mr. Ashok Shahane suggested that in the business plan expected achievement figures should come in 4th Column of the plan, which will provide that how strong the council is proceeding towards the targets. He also assured that all GC members and NSDC will provide the complete support to achieve the targets. Dr. Babu lal added that the actual achievement should be also part of Target V/s. achievement sheet. GC advised the O-CEO to incorporate the suggestions in the given sheets.

New Business plan for Q-3 and Q-4 was presented for the approval of Governing Council. With the permission of the chair Mr. Nagendra Goel (Founder Chairman, IASC) shared his views that as per the IASC Sector Skill council is concern and the New education policy have introduced we have to redesign the process of our QPS which will be now designed for the colleges and universities. He added that 60% to 70% of the QPs should be on level 6 onwards and the council has to align with the technical universities and closely work with them. Being the technical council the QPs should have the clear demarcation in 2 manners, One the QPs should be for Graduates and second for CBSE and ITI's level. Mr. Goel informed the GC that in next NOS committee meeting the council will redesigned the QPs which should go beyond Level 5 and above as the Government focus is on R&D sector , designing and Development . Mr. Ashok Shahane has endorsed the suggestions given by Mr. Goel and appreciates the work done by the council under his supervision. He also instructed to Mr. Mohan Reddy to arrange the webinars related to the suggestions given by Mr. Goel.

Mr. Avijit Das raised the question that under the current scenario how the figure of 1,20,000 candidates under RPL will be achieved ? In reply of the same O-CEO has communicated that the RPL numbers are worked out on the basis of state skill development missions such as UPSDM, BSDM, JSDM, PSDM, ASDM, PMKVY and with association like AIMA for MSME paid RPL Programme.

Mr. Nagendra Goel added that various associations like cement, Paper, Sugar, Steel, AIMA, CII, NSIC etc. have consolidated their manpower to be certified under paid RPL programme. Mr. Ashok Shahane appreciated the planning suggested by Mr. Goel. He also updated that most of our QPs are now creating for industry 5.0 to move with colleges and universities. Mr. Ashok Shahane and GC members appreciated the efforts made my Mr. Ashok Bhattacharya for his contribution to council.

Chairman, Mr. Anupam Jaiswal added that the focus should also be given on ordnance factories like Kanpur etc. GC members appreciate the suggestion given by the chairman.

Dr. Babu Lal said that all the QPs which are under development are very relevant, such as high end security surveillance and autonomous Robotics experts should be on level 6, 7 & above. Mr. A. K. Jain appreciated that the council is moving towards the right direction and is on fast track.

4. Approval of HR Policy (Amendment V-1.0)

Reference to the last GC Meeting Mr. Mohan Reddy (Representative-NSDC) had advised to incorporate the process for selection of CEO/COO in HR Policy. Members were also requested to provide their inputs related to HR Policy. Mr. Nagendra Goel (Founder Chairman) had suggested that Daily Allowance/Travel Allowance should be clearly defined in the Policy along with the details of Privilege Leaves. Based on the same the suggestions were put up in front of HR Committee on dated 25th July 2020 and the amendments have been incorporated. The amended version 1.0 is enclosed herewith (Annexure-1) for the approval of Governing Council. GC advised the officiating CEO to take the approval by circulation.

5. Inclusion of top 5 Industry members in the Governing Council

Reference to the email received from NSDC dated 4th August '2020 regarding the Inclusion of top 5 Industry members in the Governing Council /Board of SSCs. O-CEO informed that Our Council already has the representation from BECIL, Bharat Heavy Electricals Limited, FESTO, Dept of Heavy Industry (DHI) and National Accreditation Board for Testing & Calibration Laboratories (NABL).We have send the proposal to induct 5 GC Members from the prestigious organizations i.e. Siemens Limited, Schneider Electric India, Bharat Electronics Limited, Central Electronics Limited, BOSCH, DEN and Airtel. Founder Chairman suggested that roped in more GC members from Universities as the inputs received from them will be more beneficial for council. He suggested including the Dean of IP University as GC Member. Mr. A.K. Jain appreciated the suggestion and added that Institute participation will increase the employability.
