Part II – Background and Scope of Services

- About IASC SSC: Instrumentation Automation Surveillance & Communication Sector Skill Council (IASC SSC) is the NCVET recognized awarding body working to cater to the need of skilled resources in four important industry sub-sectors namely Instrumentation, Industrial Automation, Surveillance and Communication where technologies are highly dynamic in nature. IASC SSC is working under the aegis of the Ministry of Skill Development and Entrepreneurship. The main objective of this SSC is to establish academia and industry connection so that NSQF aligned courses to be designed and train the student as per industry requirements and conduct assessment and certification of the candidates.

Part III – Bidding Terms and Pre-Qualification Criteria

1. Conditions of the Issue of RFP

- RFP is not an offer and does not carry any commitment to engage with the Developers who submits the same or any other commitment related there to.
- IASC SSC reserves the right to withdraw this RFP and change or alter any part thereof at any stage if IASC SSC feels that such action is in the best interest of the IASC SSC.
- The timing and sequence of events resulting from this RFP shall ultimately be determined by IASC SSC.
- Each applicant shall submit only one RFP.

2. IPR of the Developed as part of this RFP

- The IPR of the Developed Qualification as part of this RFP shall be solely owned by IASC SSC.
- Developers should verify the duplicity / piracy of content as per rules and regulations, no piracy is permitted.

3. Language of RFP

- The proposal and all correspondence and documents shall be written in English.

4. Pre-Qualification Criteria

The invitation for bids is open to all entities in India who fulfill pre-qualification criteria as specified below:

- a) Corporate/Organizations registered under Companies Act or Societies Registration Act or registered as a Trust / LLP and is active and operational continuously anywhere in the country for the last three years on the date of application.
- b) The prospective Developer should have a minimum of 3 years of experience in Qualification Pack and related documents (as mentioned in Part 2, scope of work) development.
- c) The prospective organization should preferably have Subject Matter Expert (SME) in Instrumentation , Industrial Automation , digital Manufacturing, Research & Development and domain (job roles listed in Annexure 1) under IASC Sector.
- d) Prospective Developer should have a valid GST number.
- e) The Developer should not have been blacklisted by any donor agency/State Government / Central Government or its agencies.
